**Summer Fun Day Camp**

*Summer Fun Day Camp is designed for FACS STUDENTS entering SrK through 4<sup>th</sup> grade in need of safe and secure "all day" summer fun without the feeling of being in school.*

**Day Camp Begins:** Wednesday, June 7th

**Day Camp Ends:** Wednesday, July 26<sup>th</sup> (No Camp: July 3rd & 4th)

**Regular Hours:** Monday - Friday, 8:00am - 3:00pm

**Extended Hours:** 7:30am - 5:30pm

**Space is limited on a first come-first served basis!**

**Activities:** No off campus field trips are planned. Children will enjoy arts and crafts, scavenger hunts, science hikes & experiments, water play and plenty of outdoor free play along with many more activities planned around a weekly theme. There will be additional fees throughout the summer to cover the cost of special on campus activities which will be kept to a minimum.

**Cost:** Registration Fee: \$65/per child

Weekly Rates: 4-5 days (M-F) \$150 / Extended Hours: \$185

3 days (M, W, & F, only) \$125 / Extended Hours: \$155

2 days (Tues. & Thurs., only) \$95 / Extended Hours \$115

Daily Rates: Half Day (5 hours daily, 9:15am-2:15pm) \$30 (48 hour notice required)

**Lunch/Snack:** Campers need to bring a sack lunch with drink, two snacks, and a water bottle each day.

**Supplies:** Backpack with: light weight jacket and an extra change of clothing. (We will inform you of other items that will be needed) Please label everything!

**Rules:** Our basic rule is: "**OBEY THE FIRST TIME**". Discipline starts at home. Discipline notes will be sent home about minor issues to help us keep everything under control. We need full authority supporting us at Day Camp. You will be notified to pick up your child immediately if your child's opposition cannot be resolved. Ongoing behavior problems will result in permanent removal from Day Camp. We seek a peaceful and happy environment for each child. Summer Camp is considered an extended service offered by FACS. All rules of FACS will be applied. Thank you for your interest in our Summer Fun Day Camp. We will provide you with more information about the program when registration and deposit are received. It is our privilege to be of service to you.

**Payments are due on Friday before the week of service. No exceptions!**

A two week notice before each expected vacation is required.

**I agree to daily pick up my child by the designated time, according to my payment plan above "OR" I will pay an emergency fee of \$20.00 for the first ten minutes and \$1.00 for each minute thereafter. I understand this rule will be strictly applied. Late pick-ups exceeding more than three times will result in a probation of an earlier pick up time for the remainder of Summer Fun Day Camp. I have read the above payment plan and agree to all guidelines.**

**Super Summer Day Camp 2017**

**I HAVE READ AND UNDERSTAND THE FOLLOWING REQUIREMENTS OF THE SUMMER DAY CAMP PROGRAM:**

1. I agree to commit to 7 (seven) weeks of service and to provide two weeks' notice before using vacation time.
  2. Pick up my child by 2:15p.m., 3:00p.m., or 5:30p.m. (depending on pay plan) to avoid late pick-up charges and possible removal of my child from Day Camp.
  3. I understand my child needs a lunch with drink, two snacks and a water bottle daily.
  4. My child is expected to obey **all** rules the "first time" with possible removal from Day Camp due to continued behavior problems.
  5. I will call Day Camp at 324-8310 or FACS at 458-5543 to notify of emergency.
  6. Payments are due Friday before the week of service the according to pay plan registered. All payments must be made out to: FACS, for: Day Camp. **Please place payments inside an envelope with child's name on the front of the envelope.** Receipts will be given for each payment.

**POLICIES AND WAIVERS/RELEASE OF CLAIMS**

FACS will not be liable for lost or stolen items while participants are using FACS facilities or are on the FACS premises.

In the event of an emergency and my emergency contact person cannot be reached, I hereby give permission to FACS to transport my child to a medical emergency room for treatment. I also give permission for my child to participate in all activities for which he/she is registered. To the best of my knowledge, my child is in good health and able to participate in all Crusader Camp activities.
